ASSIGNMENT OF TRADEMARK REGISTRATIONS

NOW, THEREFORE, for good and valuable consideration, as fully described in the Asset Purchase Agreement entered into by these parties on March 7, 2014 (the "APA"), Assignor hereby assigns, transfers and conveys to Assignee the entire right, title, interest in and to the Trademarks in the United States, Canada, and all jurisdictions outside the United States and Canada, together with the goodwill of the business(es) connected with and symbolized by the Trademarks (including, without limitation, the right to renew any registrations included in the Trademarks, the right to apply for trademark registrations within or outside the United States and Canada based in whole or in part upon the Trademarks, any priority right that may arise from the Trademarks, all rights to police, monitor, and enforce the Trademarks against any and all past, current, and/or future infringements, including, without limitation, the right to sue for and collect damages caused by an such infringement, and any and all further privileges in the United States, Canada, and throughout the world to establish use, ownership, and/or registration of the Trademarks), the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this assignment, transfer and conveyance not been made, all in accordance with and subject to the APA.

Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office, the Trademark Branch of the Canadian Intellectual Property Office, and in any applicable jurisdictions outside the United States and Canada to record the transfer of the registrations set forth on Schedules A and B to Assignee as assignee of Assignor's entire right, title and interest therein and to issue any and all trademark registrations, amended registrations, and/or renewals that may be granted upon any application or petition for the Trademarks to Assignee and/or Assignee's successors and/or assigns. Assignor agrees to execute any additional documents as are reasonably necessary or as Assignee reasonably requests from time to time to effect this assignment or to confirm Assignee's ownership of the Trademarks.

This Assignment of Trademark Registrations may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts taken together shall constitute one and the same instrument. Each counterpart may be delivered by facsimile transmission or by transmission in portable document format ("PDF"), which transmission shall be deemed to constitute a valid, binding and enforceable delivery of an originally executed document.


