RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of March 11, 2014 (“Effective Date”) by **GENERAL ELECTRIC CAPITAL CORPORATION**, a Delaware corporation, acting in its capacity as Administrative Agent (“Grantee”), in favor of **GLOBAL HEALTHCARE EXCHANGE, LLC** (“Grantor”).

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of July 1, 2010 (the “2010 Trademark Security Agreement”), Grantor assigned, transferred and conveyed to Grantee, and granted to Grantee, a security interest in all of Grantors’ right, title and interest in and to the Intellectual Property Collateral (as defined in the 2010 Trademark Security Agreement);

WHEREAS, the 2010 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 1, 2010, at Reel 4235, Frame 0551;

WHEREAS, Grantee has consented to the release of the security interest on the Collateral listed on Schedule 1 hereto (the “Subject Intellectual Property Collateral”);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Grantee’s security interest in the Subject Intellectual Property Collateral granted pursuant to the 2010 Trademark Security Agreement is hereby terminated and released.



To the extent Grantee retains any such interest, Grantee hereby assigns, transfers and conveys to Grantors, all of Grantee’s right, title and interest, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interest and collateral assignment in the Subject Intellectual Property Collateral. Such assignment, transfer and conveyance by Grantee is made without any representation or warranty (express or implied) by Grantee.

3. Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release, all at the expense of Grantors.
