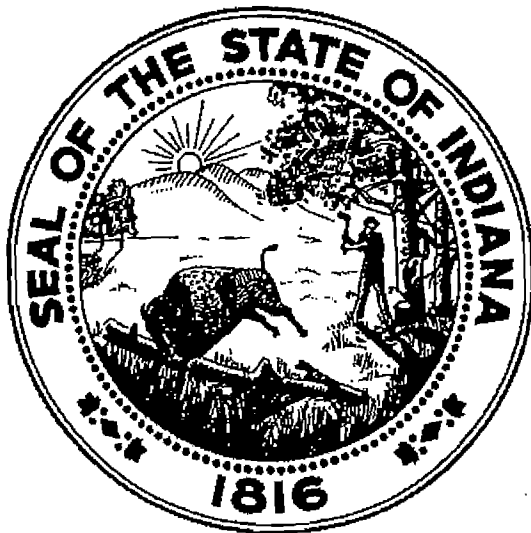

Pacers Basketball Corporation, an Indiana corporation (the "Company"), desiring to convert into an Indiana limited liability company pursuant to Chapter 38.5 of the Indiana Business Corporation Law (the "IBCL"), submits these Articles of Entity Conversion which set forth the following facts:

ARTICLE I  
Name of Company

The name of the Company immediately before the conversion becomes effective is Pacers Basketball Corporation. The name to which the name of the Company is to be changed is Pacers Basketball, LLC.

ARTICLE II  
Type of Entity

As a result of the conversion, Pacers Basketball, LLC, the surviving entity, will be an Indiana limited liability company.

ARTICLE III  
Adoption and Approval

The Plan of Entity Conversion attached hereto as Exhibit A was duly adopted and approved by joint unanimous written consent of the sole shareholder and the directors of the Company on the 30th day of January, 2009, in accordance with the Company's Articles of Incorporation and Chapter 38.5 of the IBCL.

ARTICLE IV  
Articles of Organization

The Articles of Organization attached hereto as Exhibit B shall be the Articles of Organization of the Company immediately after the conversion becomes effective.

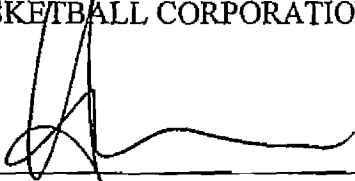
**ARTICLE IV**
