Class A Common Shares

1. Voting

- (a) The holders of the Class A Common Shares are entitled to receive notice of, attend and vote (in person or by proxy) at all meetings of the shareholders of the Company, except where holders of another class are entitled to vote separately as a class as provided in the *Business Corporations Act* (Ontario) (the "Act").
- (b) Each Class A Common Share entitles the holder to one vote at any meeting at which the holders of the Class A Common Shares are entitled to vote.

2. Dividends

The holders of the Class A Common Shares are entitled to such dividends as the directors of the Company may declare from time to time on the Class A Common Shares, in their absolute discretion and to the exclusion of the Class B Common Shares, from funds legally available for dividends. Any such dividends are payable by the Company as and when determined by the directors of the Company, in their absolute discretion.

3. Preference on Liquidation, Dissolution or Winding-Up

In the event of the liquidation, dissolution or winding-up of the Company, whether voluntary or involuntary, or any other distribution of assets of the Company among its shareholders for the purpose of winding up its affairs, the holders of the Class A Common Shares shall be entitled to participate pro rata with the holders of the Class B Common Shares in any distribution of all the remaining property or assets of the Company.

Class B Common Shares

4. Non-Voting

The holders of the Class B Common Shares are not entitled to receive notice of, attend or vote at any meeting of the shareholders of the Company, and the Class B Common Shares carry no voting rights, except as otherwise provided in the Act.

5. Dividends

The holders of the Class B Common Shares are entitled to such dividends as the directors of the Company may declare from time to time on the Class B

Common Shares, in their absolute discretion and to the exclusion of the Class A Common Shares, from funds legally available for dividends. Any such dividends are payable by the Company as and when determined by the directors of the Company, in their absolute discretion.

6. **Preference on Liquidation, Dissolution or Winding-Up**

In the event of the liquidation, dissolution or winding-up of the Company, whether voluntary or involuntary, or any other distribution of assets of the Company among its shareholders for the purpose of winding up its affairs, the holders of the Class B Common Shares shall be entitled to participate pro rata with the holders of the Class A Common Shares, in the distribution of all of the remaining property and assets of the Company.

11. The issue, transfer or ownership of shares is/is not restricted and the restrictions (if any) are as follows:

Securities of the Corporation, other than non-convertible debt securities, may not be transferred unless:

(a) (i) the consent of the directors of the Corporation is obtained; or (ii) the consent of shareholders holding more than 50% of the shares entitled to vote at such time is obtained;
or

(b) in the case of securities, other than shares, which are subject to restrictions on transfer contained in a security holders' agreement, such restrictions on transfer are complied with.

The consent of the directors or the shareholders for the purposes of this section is evidenced by a resolution of the directors or shareholders, as the case may be, or by an instrument or instruments in writing signed by all of the directors, or shareholders holding more than 50% of the shares entitled to vote at such time, as the case may be.

13. The corporation has complied with subsection 180(3) of the *Business Corporations Act*.
