

ORDER OF APPROVAL OF MERGER

In a letter dated July 1, 2013, Blue Cross and Blue Shield of Michigan ("BCBSM"), and Blue Cross Blue Shield of Michigan Mutual Insurance Company ("New BCBSM"), petitioned the Michigan Director of the Department of Insurance and Financial Services ("Director") for approval of the proposed merger of BCBSM with and into New BCBSM, pursuant to Section 220(2)(b) of Public Act 350 of 1980, as amended ("P.A. 350"). A proposed Agreement and Plan of Merger was filed as part of the petition. After reviewing the facts of the matter, the Director FINDS and CONCLUDES as follows:

- 1. BCBSM is a nonprofit health care corporation organized under P.A. 350 and authorized to transact the business of insurance in Michigan.
- 2. New BCBSM is a nonprofit mutual disability insurer organized under Chapter 58 of the

Michigan Insurance Code and pursuant to Section 220(1) of P.A. 350.

3. The terms of the Agreement and Plan of Merger are reasonable and just.

4. At the time of the merger of BCBSM with and into New BCBSM, New BCBSM will be the surviving entity and BCBSM will cease to exist as an entity. The merger will be effective 11:59 p.m. on December 31, 2013.

Therefore, based upon the above Findings of Fact and Conclusions of Law, it is hereby ORDERED that:

1. Approval of the merger of BCBSM with and into New BCBSM, in accordance with the terms and conditions of the Agreement and Plan of Merger is hereby granted.

2. BCBSM shall be dissolved, effective at the date and time the merger is effective, and certificates of authority must be returned to the Department of Insurance and Financial Services.

 A certificate of merger and other appropriate documents executed in accordance with the provisions of P.A. 350 must be filed with the Department of Insurance and Financial Services.
