RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Assignee desires to release its security interest in and lien on any and all trademarks and trademark applications owned by the Released Assignors, including those set forth on Schedule A hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignee does hereby release its security interest in and lien on any and all trademarks and trademark applications owned by the Released Assignors, including those set forth on Schedule A hereto, and reassigns to the Released Assignors all rights, titles and interests of Assignee in and to such trademarks and trademark applications.
