Assignor agrees, without further consideration, to execute all oaths, declarations, assignments, powers of attorney, applications, and other documents necessary or desirable to secure to Assignee the right, title and interest conveyed herein, and to take any further action as may be reasonably requested by the Assignee to carry out the provisions, purposes of this Assignment, including without limitation, the execution of any and all further assignments with respect to the Marks, which assignments shall be in a form acceptable for recordation in both the U.S. Patent and Trademark Office and in foreign trademark offices.

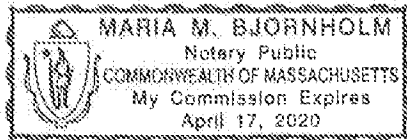

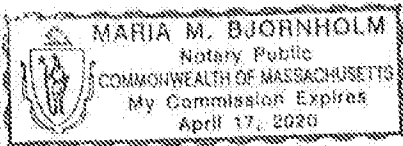
