TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this “**Agreement**”) is made and entered into as of March 13, 2014 by NewBay Media LLC, a Delaware limited liability company (“**Grantor**”), in favor of Kayne Anderson Senior Credit Advisors, LLC, in its capacity as collateral agent for the Lenders party to the Credit Agreement (together with its successors and assigns, in such capacity, “**Grantee**”):

W I T N E S S E T H:

WHEREAS, Grantor, the persons or entities as may from time to time become parties thereto as lenders (the “**Lenders**”), Grantee and others are parties to that certain Credit and Guaranty Agreement, dated as of even date herewith (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “**Credit Agreement**”), providing for loans and other financial accommodations to be made to Grantor by the Lenders, and that certain Pledge and Security Agreement, dated as of even date herewith (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”); and

WHEREAS, pursuant to the terms of the Security Agreement, Grantor has granted to Grantee, for the benefit of the Lenders, a security interest in substantially all of the assets of Grantor including all right, title and interest of Grantor in, to and under all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos and other source or business identifiers, and the goodwill associated therewith, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith (other than “intent to use” applications until a verified statement of use is filed with respect to such applications), or otherwise and all renewals thereof (the “**Trademarks**”), whether now owned or existing or owned, acquired, or arising hereafter, and all Proceeds of any and all of the foregoing, to secure, inter alia, the payment of all amounts owing by Grantor under the Credit Agreement.

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Grantor agrees as follows:

1. Incorporation of Credit Agreement and Security Agreement. The Credit Agreement and the Security Agreement and the terms and provisions thereof are hereby incorporated herein in their entirety by this reference thereto. All terms capitalized but not otherwise defined herein shall have the same meanings herein as in the Security Agreement.

2. Grant and Reaffirmation of Grant of Security Interests. To secure the payment and performance of the Obligations, Grantor hereby grants to Grantee, for the benefit of the Lenders, and hereby reaffirms its prior grant pursuant to the Security Agreement of, a continuing security interest in Grantor’s entire right, title and interest in, upon and to the following (all of the following items or types of property being herein collectively referred to as the “**Trademark Collateral**”), whether now owned or existing or owned, acquired or arising hereafter:

(i) all Trademarks, including without limitation each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof; and

(ii) all Proceeds of any and all of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

3. Termination. Upon (i) the payment in full of the outstanding Obligations, the cancellation of all outstanding Letters of Credit (or the provision of cash collateral, standby letter(s) of credit or appropriate indemnification agreement with respect thereto), and the termination of all of the Lenders' Commitments under the Credit Agreement and (ii) termination of the Security Agreement, Grantee shall execute, acknowledge, and deliver to Grantor an instrument in writing in recordable form releasing the collateral pledge, grant, assignment, lien and security interest in the Trademark Collateral under this Agreement.


