RELEASE OF SECURITY AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Security Agreement, and hereby terminates, cancels and releases any and all pledges and security interests it has against the Intellectual Property Collateral, without recourse or representation or warranty, express or implied, including the following (together with the Intellectual Property Collateral, the "Released Collateral"):

- (a) all patents, patent applications and like protections including, without limitation, improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same, including without limitation the patents and patent applications set forth on Exhibit A attached hereto (collectively, the "Patents");
- (b) any trademark and servicemark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Grantor connected with and symbolized by such trademarks, including without limitation those set forth on Exhibit B attached hereto (collectively, the "<u>Trademarks</u>");
- (i) all amendments, extensions, renewals and extensions of any of the Trademarks or Patents..

Grantee authorizes the Grantor or its representative to file this Release of Security Agreement in the United States Patent and Trademark Office.
