NOW THEREFORE, TO ALL TO WHOM IT MAY CONCERN, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign to Assignee, nunc pro tunc as of September 19, 2013, all right, title, and interest in and to the Marks, together with the goodwill of the business symbolized by the Mark, all common law rights relating thereto.
