## Release of Grants of Trademark Security Interests

This Release of Grants of Trademark Security Interests is executed as of March 17, 2014, by BNP Paribas, as Administrative Agent for the Lenders (the "**Secured Party**"), for the benefit of Hudson Products Corporation (the "**Grantor**"). Whereas, pursuant to a Grant of Trademark Security Interest dated as of August 25, 2008 (the "**2008 Trademark Agreement**"), Grantor has granted a security interest in its right, title and interest in and to the trademarks set forth in Schedule A attached hereto (the "**2008 Released Collateral**"), which 2008 Trademark Agreement was recorded with the United States Patent and Trademark Office;

Whereas, pursuant to a Grant of Trademark Security Interest dated as of December 7, 2012 (the "**2012 Trademark Agreement**" and, together with the 2008 Trademark Agreement, the "**Agreements**"), Grantor has granted a security interest in its right, title and interest in and to the trademarks set forth in Schedule B attached hereto (the "**2012 Released Collateral**" and, together with the 2008 Released Collateral, the "**Released Collateral**"), which 2012 Trademark Agreement was recorded with the United States Patent and Trademark Office; and

Whereas, the Secured Party wishes to release the security interest in the Released Collateral.

Now, Therefore, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party does hereby release, transfer and assign, without recourse, unto Grantor its lien on and security interest in and to all of each of the Grantor's right, title and interest in, to and under all of the Released Collateral.

The Secured Party authorizes the recordation of this Release with the United States Patent and Trademark Office and any other applicable registry, filing of Uniform Commercial Code financing statements and the filing or recording of any other document or instrument necessary to place on record the release of the Secured Party's security interest in all of Grantor's right, title and interest in and to the Released Collateral.

The Secured Party agrees to provide Grantor with any additional authorization necessary to effect the release of its security interest in the Released Collateral or any other security interest granted under the Agreements.
