Pursuant to Section 55-11-01 and 55-11-05 of the Business Corporation Act of the State of North Carolina, the undersigned does hereby submit the following Articles of Merger as the surviving business entity in a merger between two or more business entities:

FIRST: The name of the surviving entity is Capital Bank Financial Corp. ("CBF"), a corporation incorporated under the laws of Delaware.

SECOND: The address of the surviving foreign business entity is 121 Alhambra Plaza, Suite 1601, Coral Gables, Florida 33134. The surviving foreign entity will file a statement of any subsequent change in its mailing address with the North Carolina Secretary of State.

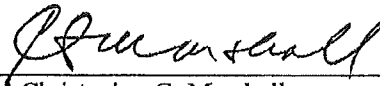
THIRD: The name of the merged entity is Capital Bank Corporation ("Capital Bank"), a corporation organized under the laws of North Carolina.

FOURTH: The Agreement and Plan of Merger, dated as of September 1, 2011, by and between CBF and Capital Bank, has been duly approved in the manner required under the laws of Delaware and North Carolina by CBF and Capital Bank.

FIFTH: The Merger shall be effective at the time of the filing of these Articles of Merger.
