**TERMINATION OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of January 31, 2014, is made by Bank of America, N.A., as successor in interest to Citicorp North America, Inc., Collateral Agent, successor in interest to Citicorp USA, Inc. (the "Secured Party").

**WHEREAS**, Amsted Industries Incorporated, Amconstruct Corporation, Amrail Corporation, Amvehicle Corporation, ABC Rail Products China Investment Corporation, ASF-Keystone, Inc., ASF-Keystone Mexico Holding Corp., Baltimore Aircoil Company, Inc., Brengo, Incorporated, Burgess-Norton Mfg. 
1. all of Grantors' Trademarks identified on Schedule A attached hereto;
