**RELEASE OF ASSIGNMENT FOR SECURITY OF TRADEMARK**

Lender consents and agrees to execute and deliver, at the request and cost of Borrower, such further instruments, documents and release forms as Borrower may reasonably request to

more effectively, release, terminate and extinguish any such liens and security interests upon such Trademarks.

This Release shall be binding upon Lender's legal representatives, assigns and successors.


