BACKGROUND

- (A) The Assignor is the proprietor of the trade marks registered or the subject of applications for registration in the United States of America and Canada listed in the attached schedule (Trade Marks).
- (B) The Assignor has agreed to assign all its rights in and to the Trade Marks to the Assignee on the terms set out below.

AGREED TERMS

1. ASSIGNMENT

Assignee or the nominee of the Assignee to secure a full assignment of the Trade Marks hereby assigned.

3. GOVERNING LAW AND JURISDICTION

This assignment shall be governed by and construed in accordance with the laws of England and the parties submit to the jurisdiction of the English courts.
