Assignors agree, without further consideration but at Assignee's sole expense, to take such actions, including, without limitation, the execution, acknowledgment and delivery of documents, as may be necessary, appropriate or reasonably requested by Assignee to further effectuate the assignment contemplated herein. Assignors further authorize the Director of the United States Patent and Trademark Office to record the Trademarks and registrations and title thereto as the property of Assignee, its successors, legal representatives and assigns in accordance with the terms of this Assignment.

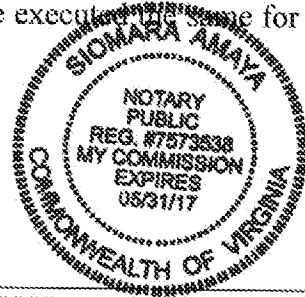

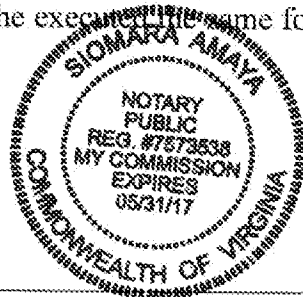
