## RELEASE OF SECURITY INTEREST IN TRADEMARKS

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of March 18, 2014 ("Effective Date") between HSBC BANK USA, NATIONAL ASSOCIATION, in its capacity as administrative agent (the "Administrative Agent"), and MILLENNIUM INORGANIC CHEMICALS LIMITED, an English private limited company (the "Grantor").

**WHEREAS**, pursuant to a First Lien Trademark Security Agreement between the Administrative Agent and the Grantor, dated as of May 15, 2007 (the "Trademark Security Agreement"), the Administrative Agent was granted a security interest in all of the Grantor's right, title, and interest in, to, and under the Trademark Collateral (as defined in the Trademark Security Agreement) set forth in the attached Schedule A;

**WHEREAS**, the Administrative Agent recorded the Trademark Security Agreement on July 3, 2007 with the United States Patent and Trademark Office ("PTO") at **Reel 3573, Frame 0567**; and

**WHEREAS**, the Grantor has requested that the Administrative Agent release its security interest under the Trademark Security Agreement and the Administrative Agent has agreed to do so.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby terminates its security interest in the Trademark Collateral originally granted to the Administrative Agent pursuant to the Trademark Security Agreement and all such interests are hereby reassigned to the Grantor without representation or warranty of any kind.
