ASSIGNMENT OF REGISTERED TRADEMARKS

WHEREAS, on or about May 31, 2013 Polymerica, LLC, f/k/a Polymerica, Inc. ("Polymerica") ceased all operations.

WHEREAS, on January 2, 2014 Christopher Horger ("Mr. Horger") obtained a Default and Summary Judgment (the "Judgment," copy attached hereto) against Polymerica from the Jefferson (Kentucky) Circuit Court, Division 13, Case No. 13-CI-002818; and

WHEREAS, prior to entry of the Judgment, Mr. Horger owned, and continues to own, a ten percent (10%) non-voting membership interest in Polymerica;

WHEREAS, prior to entry of the Judgment, Mr. Horger held a perfected security interest in all of Polymerica's assets, including but not limited to its trademarks, all as evidenced in the Security Agreement attached as Exhibit A to the Judgment; and

WHEREAS, the Judgment entitles Mr. Horger to enforce his security interest in Polymerica's trademarks; and

WHEREAS, Polymerica has adopted, used and is the owner of the following trademarks now registered in the United States Patent and Trademark Office:
