RELEASE SECURITY INTEREST IN TRADEMARKS
(REEL/FRAE NOS. 03810/0001; 04006/0646; AND 04158/0020)

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of March 12th, 2014 (the "Effective Date"), is made by Citibank, N.A., in its capacity as ABL Collateral Agent and Term Loan Collateral Agent (hereinafter, referred to as "Collateral Agent"), in favor of SABIC Innovative Plastics IP B.V. ("Grantor").

WHEREAS, pursuant to that certain ABL Security Agreement (the "ABL Security Agreement") and Term Loan Security Agreement (the "Term Loan Security Agreement"), each dated as of August 31, 2007 (collectively, the "Collateral Agreements"), among Collateral Agent, Grantor and certain other parties thereto, Grantor granted to Collateral Agent, in its capacity as ABL Collateral Agent and Term Loan Collateral Agent, a security interest in all right, title and interest in and to certain trademark registrations and applications held by Grantor; all capitalized terms used, but not otherwise defined in this Release, shall have the meanings set forth in the Collateral Agreements;

WHEREAS, pursuant to the terms of the Collateral Agreements and the Intercreditor Agreement, dated as of August 31, 2007, between the ABL Collateral Agent and the Term Loan Collateral Agent (the "Intercreditor Agreement"), the Collateral Agent and Grantor entered into (A) Intellectual Property Security and Sub-Agent Appointment Agreement, dated as of March 7, 2008 and effective as of August 31, 2007 (the "IP Security Agreement"), (B) Trademark Security Agreement Supplement, dated as of June 16, 2009 (the "First Trademark Supplement") and (C) Trademark Security Agreement Supplement, dated as of February 9, 2010 (the "Second Trademark Supplement"; collectively, together with the IP Security Agreement and the First Trademark Supplement, the "Trademark Security Agreements");

WHEREAS, the Trademarks Security Agreements were recorded with the United States Patent and Trademark Office as follows: (A) IP Security Agreement at Reel 03810/Frame 0001; (B) First Trademark Supplement at Reel 04006/Frame 0646; and (C) Second Trademark Supplement at Reel 04158/Frame 0020;

WHEREAS, Grantor has requested, and Collateral Agent has agreed, in its capacity and authority as Collateral Agent appointed under the IP Security Agreement, to release the security interest granted by Grantor to Collateral Agent under the Trademark Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:


1. Release. Collateral Agent, in its capacity as ABL Collateral Agent and Term Loan Collateral Agent, without any warranty or recourse of any kind, hereby terminates the Trademark Security Agreements, and hereby releases any and all security interests Collateral Agent has in and to the trademark registrations and trademark applications identified on Schedule A attached hereto (the "Released Trademarks") arising under the Trademark Security Agreements. If and to the extent Collateral Agent has acquired any right, title or interest to any of the Released Trademarks, it hereby re-assigns and re-transfers such right, title or interest, together with all of the goodwill associated therewith, to Grantor.

2. Further Assurances. Collateral Agent agrees take all further actions, and provide to Grantor and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably

requested by Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
