RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of January 19, 2012 in favor of Capital Safety, Inc., a Delaware corporation ("Capital Safety") and D B Industries, Inc., a Minnesota corporation ("D B Industries" and together with Capital Safety, each a "Grantor" and collectively, the "Grantors") by Bank of Scotland plc (formerly known as The Governor and the Company of the Bank of Scotland), as Security Agent (the "Security Agent").

RECITALS

- A. The Grantors have heretofore granted to the Security Agent a lien on and security interest in all of its right, title and interest in and to the trademarks, trademark registrations and trademark applications, including but not limited to those trademarks, trademark registrations and trademark applications set forth on Schedule A hereto, to secure the Secured Obligations (as defined in that certain Pledge and Security Agreement among the Grantors, Redwing US Inc., the other grantors from time to time party thereto and the Security Agent, dated June 14, 2007, as amended, modified, restated and/or supplemented (the "Pledge and Security Agreement").
- B. Pursuant to the Pledge and Security Agreement, the Grantors executed an intellectual property security agreement (the "IP Security Agreement"), in which the Grantors granted to the Security Agent a lien on and security interest in all of its right, title and interest in, to and under certain intellectual property, including those trademarks set forth on Schedule A hereto (the "Trademarks").
- C. The Security Agent recorded the IP Security Agreement with the United States Patent and Trademark Office on August 7, 2007, at Reel 3595, Frame 0821 for the purpose of recording its security interest in and lien on the Trademarks.
- D. The Security Agent now wishes to release and restore all right, title and interest in and to the Trademarks to the Grantors and to dissolve any and all liens and encumbrances respecting the Trademarks.

SECTION 1 Defined Terms

Unless otherwise defined herein, terms defined in the Pledge and Security Agreement and used herein have the meaning given to them in the Pledge and Security Agreement.

SECTION 2 Release

For good and valuable consideration, receipt of which is hereby acknowledged, the Security Agent hereby, on behalf of itself and the Secured Parties (as defined in the Pledge and Security Agreement), (i) terminates the (x) Pledge and Security Agreement and (y) IP Security Agreement, (ii) terminates, cancels and releases any and all liens and security interests it has in, to and under the Trademarks, (iii) re-assigns to the Grantors any right, title and interest it may have in, to and under the Trademarks, and (iv) authorizes and requests that the United States Patent and Trademark Office, and any other location where the security interest was filed, note and record the existence of such release hereby given.


