Nunc Pro Tunc Trademark Assignment

WHEREAS, Nyamekye North America, LLC, a Delaware limited liability company ("Assignor"), under its former name, Exigence North America, LLC, was the owner of the trademark represented by registration with the United States Patent and Trademark Office of the mark EXIGENCE (Reg. No. 3,594,011), (collectively the "Mark") until the effective date of the transaction referenced in the next paragraph below; and

WHEREAS, as part of an asset and equity purchase agreement executed on April 30, 2012, ("Effective Date") Assignor assigned, transferred, granted and conveyed all right, title and interest in or related to the Mark, together with the goodwill associated therewith, to purchaser Exigence-TH Acquisition, Inc., a New York company ("Assignee"); and

WHEREAS, Exigence-TH Acquisition, Inc. changed its name to Exigence Management Company, Inc. on June 2, 2012; and

WHEREAS, Assignor and Assignee now desire to memorialize Assignee's acquisition of Assignor's right, title, and interest in or related to the Mark, together with the goodwill associated therewith, and further to assign, transfer, grant and convey all right, title and interest in or related to the Mark that may, the foregoing notwithstanding, remain in Assignor;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee have caused this *Nunc Pro Tunc* Assignment to be executed with the effect of memorializing and confirming the assignment referenced above, effective April 30, 2012, and to assign, transfer, grant and convey all of Assignor's right, title and interest in or related to the Mark, together with the goodwill of the business symbolized by the Mark, to Assignee, for Assignee to hold, for the benefit of itself, its successors and assigns, to be effective as of the Effective Date.


