TRADEMARK ASSIGNMENT WITH RESERVATION OF ROYALTY

WHEREAS, Bobbie Fitzner, an individual residing at 906 Rock Street, Bowie, Texas 76320, hereinafter referred to as ASSIGNOR, owns the entire right, title, and interest in and to the trademarks, service marks, and/or trade names listed on the attached Schedules A and B ("Trademarks"), whether registered or not, together with all of the goodwill associated therewith and symbolized thereby, including all common-law rights associated with the Trademarks by virtue of their use in commerce;

WHEREAS, DFK Enterprises, Inc., a corporation formed pursuant to the laws of the State of Texas, hereinafter referred to as the ASSIGNEE, is desirous of acquiring said Trademarks, whether registered or not, together with all of the goodwill associated therewith and symbolized thereby, including all common-law rights associated with the Trademarks by virtue of their use in commerce; and

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, in consideration of the payment of \$1.00 (One Dollar) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR assigns and delivers to ASSIGNEE, its successors, and assigns his rights in the Trademarks, and all of the goodwill associated therewith and symbolized thereby, including any and all rights to register and to renew the Trademarks, together with all rights to sue and recover for past infringement thereof, to have and to hold forever for the sole and exclusive use and benefit of ASSIGNEE, its successors or assigns. This assignment is subject to the reservation of interest set forth below.

RESERVATION OF INTEREST. ASSIGNOR, hereby reserves unto himself, his heirs and assigns, thirty percent (30%) of one hundred percent (100%) of all consideration, including, but not limited to, gross income, gross royalties, and gross proceeds to be derived by ASSIGNEE for the use, sale, assignment, or licensing of the Trademark (hereinafter referred to as "Royalty").

RIGHT TO ASSIGN. ASSIGNOR has the right to assign all or part of the Royalty reserved in this document. Upon receipt of an assignment by ASSIGNOR to another person or entity, ASSIGNEE will commence, as of the effective date of the assignment, all Royalty consideration to the new assignee in an amount equal to the interest ASSIGNOR has assigned to the new assignee. The new assignee may make further assignments of its interest and those assignments will be binding upon ASSIGNEE upon the same terms as are set forth in this document.

DUTY TO ACCOUNT. Any ASSIGNOR or person or entity to whom ASSIGNOR has assigned an interest in the Royalty has the right for a period of two years after receipt of payment to audit accounts and records relating to such payment. The party conducting such audit bears its costs of the audit. ASSIGNEE has a duty to provide an accounting to any holder of an interest in the Royalty of any and all proceeds from the use, including, but not limited to any, sale, licensing, or assignment, of the Mark owed to or received by ASSIGNEE.


