**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby terminates and releases all of its security interests in and liens on all of the Trademark Collateral granted in the Security Agreement and the Grant of Security Interest, and the undersigned hereby acknowledges and agrees that it has no further interests in such Trademark Collateral and that such Security Agreement and Grant of Security Interest are terminated and of no further force and effect.
