Resolved: That the Corporation shall change its name to "It's Elation, Inc."

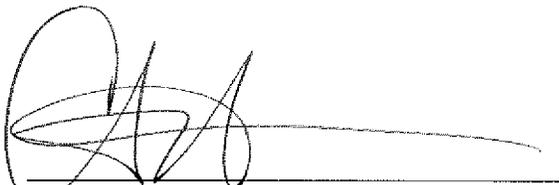

The undersigned, constituting all of the members of the Board of Directors shall recommend adoption of the resolution to all Shareholders of the Corporation.

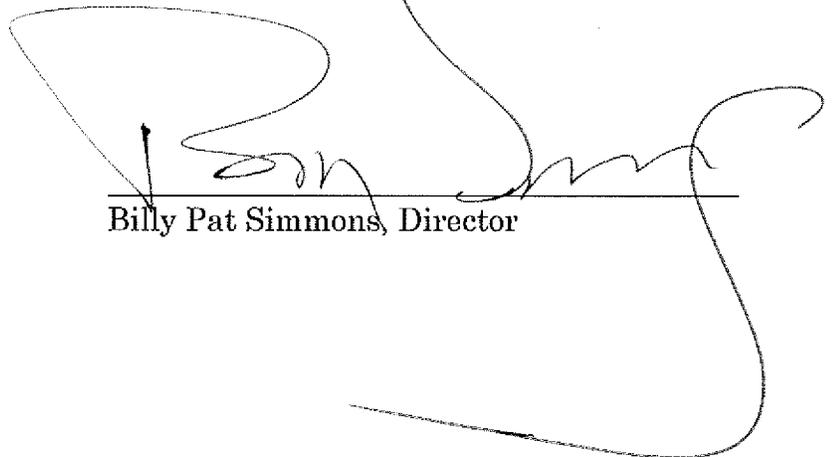
The undersigned further hereby waive any notice that may be required and consent to, vote in favor of, and adopt the aforementioned resolution by unanimous written consent.
