RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is made as of March 26, 2014, by The Huntington National Bank ("Lender") in favor of Terry's Tire Town, Inc., an Ohio corporation ("Borrower").

WITNESSETH:

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated November 23, 2010, by and among Borrower and Lender (the "Security Agreement"), recorded on December 13, 2010, at Reel No. 4432, Frame 0014, United States Patent and Trademark Office, Borrower granted a security interest in certain trademarks in favor of Lender to secure certain debt owing from Borrower to Lender;
