**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is made as of March 26, 2014, by The Huntington National Bank ("Lender") in favor of Terry's Tire Town, Inc., an Ohio corporation, Summit Tires Northeast, LLC, an Ohio limited liability company, and Englewood Tire Wholesale, Inc., a New Jersey corporation ("Borrower").

**WITNESSETH:**

WHEREAS, pursuant to that certain Amended and Restated Intellectual Property Security Agreement dated November 30, 2011, by and among Borrower and Lender (the "Security Agreement"), recorded on December 5, 2011, at Reel No. 4672, Frame 0011, United States Patent and Trademark Office, Borrower granted a security interest in certain trademarks in favor of Lender to secure certain debt owing from Borrower to Lender;

WHEREAS, Borrower has requested that Lender (i) terminate and release the liens and interests of Lender in certain of Borrower's trademarks as set forth in **Exhibit A** attached hereto (collectively, the "Trademarks"), and (ii) execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office and other appropriate offices; and

WHEREAS, Lender has agreed to such release and termination.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby releases and terminates its security interests in the Trademarks, and reassigns to Borrower all right, title and interest of Lender in and to the Trademarks.
