RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Re-lease”) is made as of March 28, 2014 (the “Effective Date”), by CITIBANK, N.A., as collateral agent (in such capacity, the “Collateral Agent”), in favor of CRC HEALTH CORPORATION, a Delaware corporation and SIERRA TUCSON INC., a Delaware corporation (formerly known as CRC MERGER ACQUISITION CORP.) (each individually, a “Pledgor”, and, collectively, the “Pledgors”).

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement between the Pledgors and the Collateral Agent dated as of February 6, 2006 (the “Trademark Security Agreement”), the Pledgors pledged and granted to the Collateral Agent a lien on and security interest in all of their right, title and interest in and to certain collateral identified in said Trademark Security Agreement including, without limitation, the trademark applications set forth on Schedule I hereto, along with the goodwill associated therewith (collectively, the “Trademarks”);

WHEREAS, the Trademark Security Agreement was recorded with the Assignment Division of the U.S. Patent & Trademark Office on February 7, 2006, at Reel 3242 and Frame 0250;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Trademark Security Agreement, and hereby terminates, cancels, discharges, reassigns and releases any and all liens and security interests it has in and against the collateral, including the Trademarks, arising under the Trademark Security Agreement.


If and to the extent the Collateral Agent has acquired any right, title or interest in or to any of the Trademarks, it hereby irrevocably re-assigns and re-transfers all such rights, title and interest to the Pledgors.

The Collateral Agent shall take all further actions, and provide to the Pledgors and their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Pledgors, and at the Pledgors’ cost and expense, to more fully and effectively effectuate the purposes of this Release.
