RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS

WHEREAS, pursuant to that certain Grant of Security Interest In Trademark Rights, dated June 1, 2010 (the "Trademark Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 4228, Frame 0639 on June 21, 2010, BL Restaurant Operations, LLC, a Delaware limited liability company (the "Releasee"), granted to Bank of Montreal ("BMO") and BMO Harris Financing, Inc. (f/k/a BMO Capital Markets Financing, Inc., and together with BMO, the "Releasor") a continuing security interest in Trademarks, including the Trademarks listed on Schedule A attached hereto, together with all goodwill associated therewith and symbolized thereby and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action arising out of or relating to any infringement thereof and any and rights to recover from past, present and future violations thereof (the "IP Collateral"); and

WHEREAS, Releasee has requested and Releasor has agreed to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of evidencing the release, relinquishment, discharge and termination of Releasor's security interest in the IP Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. Release of Security Interest. Releasor hereby, without any representation and warranty, releases, relinquishes and discharges its security interest in the IP Collateral.
