**RELEASE OF TRADEMARK SECURITY INTEREST**

This **RELEASE OF TRADEMARK SECURITY INTEREST**, dated as of April 1, 2014, is made by SunTrust Bank, as administrative agent ("Grantee"), in favor of the Grantors party to the Trademark Security Agreement (as defined below).
