## TRADEMARK ASSIGNMENT AGREEMENT

**THIS TRADEMARK ASSIGNMENT AGREEMENT** ("Assignment") is entered into as of this the 3rd day of March, 2014 ("Effective Date") by and among The Texas Brahmas, L.P., a Delaware limited partnership ("Assignor"), and Texas Brahmas Youth Hockey Association, Inc. a Texas non-profit corporation and 501(c)(3) charitable organization ("Assignee").

**NOW, THEREFORE**, to all whom it may concern, be it known that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby makes the transfer and assignment of all rights in the Marks as follows:

1. Assignor hereby sells, assigns, transfers and sets over unto Assignee all of Assignor's right, title and interest, anywhere in the world, in and to the Marks and the registrations therefor, together with the goodwill of the business in connection with which the Marks are used and that part of the goodwill of the business connected with the use of and symbolized by the Marks;
2. Assignor covenants and agrees that it will, at any time upon request and at Assignee's sole cost and expense, execute and deliver any and all documents that may be reasonably necessary or desirable to perfect Assignee's rights in and to the Marks; and
3. This Assignment includes any and all rights to past and future causes of action for infringement of the marks including the right to recover damages for past infringement thereof. Assignor agrees to cooperate in any such actions, which Assignee may or may not choose to bring, to the extent reasonably required by Assignee, and at Assignee's sole cost and expense, to enforce the rights transferred hereunder.

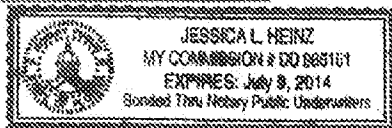
