RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "**Release**") is made as of March 31, 2014, among Eberle Design, Inc., an Arizona corporation ("**Eberle Design**"), Reno A&E, LLC, a Delaware limited liability company (collectively, with Eberle Design, the "**Grantors**") and Ares Capital Corporation, as administrative agent and collateral agent (in such capacity, the "**Administrative Agent**"), for the lenders from time to time party to the Credit Agreement, dated as of August 26, 2013 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), among EDT Holdings, Inc., a Delaware corporation ("**Holdings**"), Eberle Design, the persons from time to time parties thereto that are designated as a Credit Party, the lenders from time to time party there, the Administrative Agent and the other parties thereto. Capitalized terms used herein without definition are used as defined in the Credit Agreement and the Guaranty and Security Agreement (as hereinafter defined), as applicable.

WHEREAS, pursuant to the Guaranty and Security Agreement, dated as of August 26, 2013 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**Guaranty and Security Agreement**"), made by the Grantors, Holdings, and the other parties thereto in favor of the Administrative Agent, a security interest was granted by each Grantor to the Administrative Agent in such Grantor's Intellectual Property, including their Trademarks;

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of August 26, 2013 (the "**Trademark Security Agreement**") by the Grantors in favor of the Administrative Agent, the Grantors, by reference to the Guaranty and Security Agreement, confirmed their pledge and grant of a security interest to the Administrative Agent specifically in their Trademarks, including, without limitation, the Trademarks set forth on Schedule A hereto (the "**Released Trademarks**");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on August 28, 2013 on Reel 005099, Frame 0464; and

WHEREAS, the Administrative Agent has agreed to release its security interest in the Released Trademarks;

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademarks pursuant to the Guaranty and Security Agreement and the Trademark Security Agreement (other than any obligations, indebtedness and liabilities that expressly survive the Guaranty and Security Agreement and the Trademark Security Agreement), the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent does hereby irrevocably (a) terminate and release its security interest in the Trademarks (including, without limitation, the Released Trademarks) pledged and granted to the Administrative Agent pursuant to the Guaranty and Security Agreement and the Trademark Security Agreement, together with all of the goodwill associated therewith and reassigns and transfers any right, title and interest that the Administrative Agent may have in the Release Trademarks to the applicable Grantor and (b) acknowledge, confirm and agree that the Guaranty and Security Agreement and Trademark Security Agreement are discharged, released and terminated, and of no further force or effect with respect to the Released Trademarks, in each case, effective as of the date set forth above. This Release shall be binding upon the Administrative Agent's legal representatives, assigns and successors.

The Administrative Agent authorizes and requests that the United States Commissioner for Trademarks and any other applicable government officer record this Release. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
