**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

April 1, 2014

This Termination and Release of Security Interest in Trademark Collateral (this “Release”), dated as of the date first set forth above, is made by Jefferies Finance LLC, a Delaware limited liability company, in its capacity as administrative agent pursuant to the Credit Agreement dated June 17, 2011 (in such capacity, the “Administrative Agent”) in favor of Medpace, Inc., a Delaware corporation (the “Grantor”).

Reference is hereby made to that certain Trademark Security Agreement (the “Trademark Security Agreement”; capitalized terms used but not defined herein shall have the meanings given to them in the Trademark Security Agreement) dated as of June 17, 2011, by the Grantor, in favor of the Administrative Agent, recorded with the United States Patent and Trademark Office on June 17, 2011, at Reel/Frame No. 004565/0188, with a correction filed with the United States Patent and Trademark Office on March 28, 2014, at Reel/Frame No. 5246/0417.

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby notifies, acknowledges and agrees with the Grantor that (i) the security interest in the Trademark Collateral granted by the Grantor to the Administrative Agent for the ratable benefit of the Secured Parties pursuant to the Trademark Security Agreement, including, without limitation, the security interest granted in the trademarks listed on the attached Schedule A, is terminated, released and discharged fully, (ii) the Administrative Agent hereby releases and forever discharges fully all of its right, title and interest in, to and under, and of any kind or nature in the Trademark Collateral, including all of the goodwill of the business connected with the use of, and symbolized by the Trademark Collateral, that was granted, assigned or conveyed pursuant to the Trademark Security Agreement, and (iii) any right, title or interest of the Administrative Agent in, to and under the Trademark Collateral shall hereby cease and become void. The Administrative Agent hereby retransfers and reassigns to the Grantor, without representation or warranty, all of the Administrative Agent’s right, title and interest in, to and under the Trademark Collateral.

The Administrative Agent hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable government officer to record this Release.
