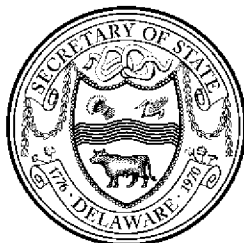



**FIRST:** The name of each constituent corporation is Duckback Acquisition Corp., a Delaware corporation, Color Wheel Paints & Coatings, Inc., a Delaware corporation, Frazee Industries, Inc., a Delaware corporation, Kwal-Howells, Inc., a Colorado corporation, Parker Paint Mfg. Company, Inc., a Washington corporation, and Stellar Acquisition Corp., a Delaware corporation.

**SECOND:** The Agreement and Plan of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with Section 252.

**THIRD:** The name of the surviving corporation is Duckback Acquisition Corp., a Delaware corporation.

**FOURTH:** The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation.

**FIFTH:** The merger is to become effective at 12:00 P.M. Eastern Standard Time on February 28, 2014.

**SIXTH:** The Agreement and Plan of Merger is on file at 101 W. Prospect Avenue, Cleveland, Ohio 44115, the place of business of the surviving corporation.

**SEVENTH:** A copy of the Agreement and Plan of Merger will be furnished by the surviving corporation on request, without cost, to any stockholder of the constituent corporations.

**EIGHTH:** The authorized stock and par value of the non-Delaware corporations is: (i) 50,000 shares of common stock, no par value, of Kwal-Howells, Inc. and (ii) 300 shares of common stock, no par value, of Parker Paint Mfg. Company, Inc.
