**NOTICE OF RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is entered into and effective as of April 1, 2014, by PNC BANK, NATIONAL ASSOCIATION, as agent for certain lenders ("Agent") in favor of THE RECEIVABLE MANAGEMENT SERVICES CORPORATION (the "Borrower").

**RECITALS**

WHEREAS, the Borrower and the Agent entered into that certain Trademark Security Agreement dated as of November 19, 2010 and recorded in the United States Patent and Trademark Office on December 29, 2010 at Reel/Frame No. 004442/0174 ("Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement, Borrower granted to the Agent, for the benefit of the Lenders (as defined in the Trademark Security Agreement), a continuing security interest in all of such Borrower's right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement); and

WHEREAS, Agent wishes to (a) terminate the Trademark Security Agreement and (b) terminate, relinquish, discharge, and cancel any or all of its security interests in, upon or against the Trademark Collateral, including the trademark registrations and applications listed on Schedule A hereto;

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, Agent hereby agrees as follows:

1. Release of Security Interest. The Agent, on behalf of itself and the Lenders, hereby (i) terminates the Trademark Security Agreement, and (ii) unconditionally and expressly discharges, terminates, cancels and releases any mortgage, pledge, hypothecation, lien or security interest it has in, upon, or against the Trademark Collateral, including the trademark registrations and applications listed on Schedule A hereto, and if and to the extent right, title, and interest in or to such Trademark Collateral was previously assigned, sold, granted, conveyed, or transferred by any Borrower to Agent, Agent hereby irrevocably assigns, sells, grants, conveys and transfers to such Borrower such right, title and interest in and to such Trademark Collateral without representation or warranty of any kind or nature except that Agent has not previously assigned, sold, granted, conveyed or transferred the Trademark Collateral.

2. Filing. The Agent hereby authorizes the Borrower or the Borrower's authorized representatives to record this Release with the United States Patent and Trademark Office in order to memorialize the release of the lien on and security interest in the Trademark Collateral, including the trademark registrations and applications listed on Schedule A hereto.


3. Further Assurances. The Agent agrees to execute, acknowledge and deliver to the Borrowers any and all further documents or instruments, and do any and all further acts, at the Borrowers' cost and expense, which the Borrower (or their respective agents or designees) reasonably request in order to confirm this Release and the Borrower's (or their assignees') right, title and interest in and to the Trademark Collateral.

4. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).
