**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of April 2, 2014 (this "Release"), is made by Bank of Montreal, as collateral agent (in such capacity, "Agent") under the Security Agreement referenced in the Amended and Restated Security Agreement described below, in favor of Flexera Software LLC (the "Debtor") as follows:

**WITNESSETH**

WHEREAS, pursuant to the Amended and Restated Trademark Security Agreement, dated March 13, 2013, and recorded with the United States Patent and Trademark Office on March 27, 2013 at Reel/Frame No. 4992/0230, the Debtor granted Agent a security interest on certain collateral pledged by Debtor described therein, including without limitation the United States trademark registrations set forth in Schedule A attached hereto (collectively, the "Trademark Collateral");

WHEREAS, the Debtor has paid all of its outstanding indebtedness to Agent; and

WHEREAS, the Debtor has requested that the Agent release its security interest in and lien on the Trademark Collateral.

NOW, THEREFORE, Agent, without recourse, representation or warranty and at the Debtor's sole cost and expense, hereby terminates, cancels and releases the security interest in the Trademark Collateral and any and all right, title and interest of the Agent in the Trademark Collateral shall hereby terminate, cease and become void.

Agent agrees to provide the Debtor with any information and additional authorization and documentation necessary to effect the release of Agent's security interest in the released Trademark Collateral without recourse, representation or warranty and at the Debtor's sole cost and expense.
