TRADEMARK RELEASE

This Trademark Release is made as of April 2, 2014, by Madison Capital Funding LLC, as administrative agent ("Secured Party") in favor of Assured Aerospace Insurance Agency, LLC, a Colorado limited liability company now known as AirSure Limited, LLC ("Grantor").

W I T N E S S E T H:

WHEREAS, Grantor and Secured Party are parties to that certain Trademark Security Agreement dated as of January 30, 2014 (the "Agreement"; capitalized terms which are not defined herein have the meaning given to such terms in the Agreement) and pursuant to which Grantor granted a security interest to Secured Party in the Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Secured Party;

WHEREAS, the Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on January 31, 2014, at Reel 5205 Frame 0154;

WHEREAS, Grantor has requested that Secured Party release its security interest all of Grantor's right, title and interest in and to the Trademark Collateral; and

WHEREAS, Secured Party has agreed to release the entirety of its security interest in all of Grantor's right, title and interest in and to the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby releases its security interest in all of Grantor's right, title and interest in and to the following, whether then owned or existing or thereafter created, acquired or arising (collectively, the "Trademark Collateral"):

- a) each Trademark listed on Schedule A annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and
- b) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (i) infringement or dilution of each such Trademark, or (ii) injury to the goodwill associated with each such Trademark.

2. Secured Party hereby authorizes the Grantor (or the Grantor's authorized representative(s)) to record this Trademark Release with the United States Patent and Trademark Office and/or any other applicable governmental office or agency in order to accomplish the release of the Secured Party's security interest as described herein.
