TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (hereinafter "Assignment Agreement") is made this 25<sup>th</sup> day of MARCH, 2014, by and between Lavetta Willis, a citizen of the United States of America (the "Assignor"), and Sovenca, S.L., a limited liability company of Spain (the "Assignee").

WHEREAS, Assignor is the owner of all right, title and interest in and to the trademark "FLOSSY" and the corresponding registration in the United States Patent and Trademark Office, U.S. Registration No. 3524902, registered on October 28, 2008 (the "Trademark"), together with the goodwill of the business connected with and symbolized by the Trademark; and

WHEREAS, Assignee desires to acquire all right, title and interest in and to the Trademark together with the goodwill of the business connected with and symbolized by the Trademark;

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereby agree as set forth below.

Assignor hereby irrevocably sells, assigns, transfers and conveys to Assignee the entire right, title, interest in and to the Trademark in the United States and all jurisdictions outside the United States, together with the goodwill of the business connected with and symbolized by the Trademark including, without limitation, all rights therein at common law, the right to renew any registrations included in the Trademark, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Trademark, the right to sue and recover damages, profits and other remedies for past and future infringement by any third party, any and all rights to royalties, profits, compensations, license fees, or other remuneration of any kind relating to the Trademark and/or the goodwill under the Trademark, and any priority right that may arise from the Trademark, the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this sale, assignment, transfer and conveyance not been made.

Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of the registrations and applications set forth above to Assignee as assignee of Assignor's entire right, title and interest therein. Assignor does further hereby give consent to Assignee to take solely in its name all necessary procedures for recording this assignment.

Assignor agrees to execute all documents, papers, forms, and authorizations and take all other action that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the registrations and applications for registration set forth above.

Assignor represents and warrants that Assignor has the full right to convey the entire right, title and interest herein assigned, and that Assignor will not take any action, use any trademark or execute any instrument or grant or transfer any rights, title or interests inconsistent with the rights, title and interests assigned herein.

Each party represents and warrants that it has full right, power and authority to enter into this Assignment Agreement and perform all of its obligations hereunder.

This Assignment Agreement may be executed in counterparts, each of which shall be deemed an original, but which together shall constitute one and the same agreement.
