**TERMINATION AND RELEASE OF IP  
SECURITY AGREEMENT**

This Termination and Release of IP Security Agreement (this "Release") is conveyed as of March 31, 2014, by PNC BANK, NATIONAL ASSOCIATION, as Agent for itself and other Lenders under the Security Agreement referred to below (in such capacity, the "Agent"), in favor of VOYETRA TURTLE BEACH, INC., a Delaware corporation ("VTB"), and PARAMETRIC SOUND CORPORATION, a Nevada corporation ("PSC" and together with VTB, each individually a "Debtor" and collectively, the "Debtors").

WHEREAS, reference is made to that certain Security Agreement, dated as of August 22, 2012 (as amended, amended and restated, supplemented or otherwise modified to the date hereof, the "Security Agreement"), by and among the Debtors, the other obligors party thereto from time to time and the Agent.

WHEREAS, Agent and VTB executed a Security Interest in U.S. Patents and Trademarks, dated August 22, 2012, which was recorded with the United States Patent and Trademark Office (the "USPTO") on August 23, 2012, at Reel 028833 Frame 0094, under which VTB granted to the Agent a security interest in its interest in the patents and patent applications listed on the attached Schedule A (collectively, the "VTB Patents").

WHEREAS, Agent and PSC executed a Security Interest in U.S. Patents and Trademarks, dated August 22, 2012, which was recorded with the USPTO on January 15, 2014, at Reel 032032 Frame 0328, under which PSC granted to the Agent a security interest in its interest in the patents and patent applications listed on the attached Schedule A (collectively, the "PSC Patents"), and together with the VTB Patents are referred to herein as the "Patents").

WHEREAS, Agent and VTB executed a Security Interest in U.S. Patents and Trademarks, dated August 22, 2012, which was recorded with the USPTO on August 23, 2012, at Reel 4848 Frame 0061, under which VTB granted to the Agent a security interest in its interest in the trademark registrations and the trademark applications listed on the attached Schedule B (collectively, the "VTB Trademarks") and the goodwill associated therewith.


WHEREAS, Agent and PSC executed a Security Interest in U.S. Patents and Trademarks, dated January 15, 2014, which was recorded with the USPTO on January 15, 2014, at Reel 5193 Frame 0544, under which PSC granted to the Agent a security interest in its interest in the trademark registrations and the trademark applications listed on the attached Schedule B (collectively, the "PSC Trademarks"), and together with the VTB Trademarks are referred to herein as the "Trademarks") and the goodwill associated therewith.

WHEREAS, the Agent wishes to terminate the Security Agreement and release, retransfer and reassign to each Debtor, without representation or warranty, all of the Agent's right, title and interest in and to the Marks and the goodwill associated therewith, and the Patents.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Agent hereby terminates the Security Agreement and releases, retransfers and reassigns to each Debtor, without representations or warranty, all of the Agent's right, title and interest in and to the Marks and the goodwill associated therewith, and the Patents.
