FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, **LANDS' END, INC.**, a Delaware corporation ("LEI") and **LANDS' END DIRECT MERCHANTS, INC.**, a Delaware corporation ("LEDM") (LEI and LEDM are hereinafter referred to, individually, as a "Grantor", and collectively, the "Grantors"), hereby grant to **BANK OF AMERICA, N.A.** (in its capacity as administrative agent and collateral agent for the Credit Parties (as defined in the ABL Credit Agreement (as defined below)), in such capacities and together with any successors in such capacities, the "Grantee"), a continuing security interest in (i) all of such Grantor's right, title and interest in, to and under the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth on Schedule A attached hereto, (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated, (iv) rights and privileges arising under applicable Law with respect to such Grantor's use of any of the foregoing, (v) extensions and renewals thereof, (vi) income, fees, royalties, damages and payments now and hereafter due and/or payable thereunder and with respect thereto, including, without limitation, damages, claims and payments for past, present or future infringements, dilution or violation thereof, (vii) rights corresponding thereto throughout the world, (viii) all causes of action and rights to sue, whether arising prior to or after the date hereof, for infringement of any of the Marks or unfair competition regarding the same, and (ix) all proceeds and products of the foregoing.


