**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

WHEREAS Joerns Healthcare, LLC, a Delaware limited liability company with an address at 2430 Whitehall Park Drive, Charlotte, NC 28273 (the "Grantor"), entered into that certain security agreement dated August 6, 2010 (the "Security Agreement") with General Electric Capital Corporation, a Delaware corporation (the "Agent"), notice of which was recorded April 1, 2013, at the United States Patent and Trademark Office at Reel 4995, Frame 0440.

WHEREAS, Grantor granted the Agent, under the terms of the Security Agreement, a continuing security interest (the "Security Interest") in favor of the Agent, in and to certain of Grantor's intellectual property, including without limitation the trademarks listed in **Schedule A** hereto, all of the goodwill of the business connected with the use of and symbolized by such trademarks, all renewals and extensions of such trademarks, and all proceeds and claims relating to same (collectively, the "Trademarks").

WHEREAS, the Agent has agreed to terminate and release its security interest in those Trademarks listed in **Schedule A** hereto.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby agrees as follows:


SECTION 1. *Release of Security Interest in Trademarks.* The Agent hereby releases, terminates and discharges all liens on and security interest in and to all of its right, title and interest in, to and under all Trademarks of the Grantor set forth on **Schedule A** hereto, hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to Grantor and its successors and assigns in association with the security interest in such Trademarks, and hereby releases Grantor and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the security interest in such Trademarks.

SECTION 2. *Recordation of Release.* The Agent hereby authorizes and requests that the Commissioner for Trademarks in the USPTO, and any other necessary United States government officer, record this Termination and Release of Security Interest in Trademarks.
