RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of April 7, 2014 (the "Effective Date"), by Rosenthal & Rosenthal, Inc., 1370 Broadway, New York, New York (the "Grantee").

WHEREAS, Judith Ripka Creations, Inc., located at, 200 Madison Avenue, 6th Fl., New York, New York 10016 (the "Grantor") entered into (i) that certain Financing Agreement, dated January 26, 2010 (the "Financing Agreement"), by and between Grantor and Grantee, and (ii) that certain Security Agreement, dated January 26, 2010 (the "Trademark Security Agreement"), with the Grantee in order to convey to Grantee a security interest in the trademarks RIPKA AND CO. and JUDITH RIPKA 18, and U.S. Trademark Registration Nos. 3357691 and 2382581, respectively, therefor (the "RIPKA Collateral");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on Reel 004139, Frame 0513; and

WHEREAS, the Grantee agrees to formally release and re-convey to the Grantor the security interest in all of Grantor's right, title and interest in and to the RIPKA Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. The Grantee hereby releases and re-conveys, without representation or warranty, to the Grantor all of the Grantor's security interest and rights that were granted to the Grantee pursuant to the Trademark Security Agreement and the Financing Agreement, respectively, in and to the RIPKA Collateral.

2. The Grantee acknowledges and affirms that all of the rights, interests, and remedies of the Grantee concerning the RIPKA Collateral pursuant to the Trademark Security Agreement and the Financing Agreement are hereby terminated.

3. This Release shall not constitute a release of Grantee's security interest in any other trademark and/or collateral under the Financing Agreement or Trademark Security Agreement, and the Financing Agreement and Trademark Security Agreement shall each otherwise continue in full force and effect, including with respect to any such other trademarks and/or collateral.


