**7. Agreement to Perform Necessary Acts.**



Assignee agrees to perform any further acts and execute and deliver any documents that may be reasonably necessary to carry out the provisions of this Agreement.

This Agreement shall be construed in accordance with, and all actions arising hereunder shall be governed by the laws of United States.




