INTELLECTUAL PROPERTY RIGHTS ASSIGNMENT

This Intellectual Property Rights Assignment (this "Assignment"), made this 8th day of April, 2014, is by and between the entity identified on the signature pages hereto as the "Assignor" having its principal place of business at the address listed on the signature pages hereto ("Assignor"), and the entity identified on the signature pages hereto as the "Assignee" having its principal place of business at the address listed on the signature pages hereto ("Assignee").

WHEREAS, the Acquired Intellectual Property includes the trademarks and trademark applications and registrations identified on the attached Schedule A (together with any and all copyright rights therein, the "Marks"), the domain name registrations and social media pages identified on the attached Schedule B (the "Domain Names") and the copyright applications and registrations identified on the attached Schedule C (the "Copyrights"); and

WHEREAS, in accordance with the Principal Agreement, Assignee desires to acquire the Acquired Intellectual Property, including the Marks and all rights therein, including the goodwill of the business associated therewith, all common law rights therein and all worldwide trademark and service mark registrations and applications therefore, including the registrations and applications identified on Schedule A, the Domain Names identified on Schedule B and the Copyrights identified on Schedule C.

NOW, THEREFORE, for good and valuable consideration provided for in the Principal Agreement, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby irrevocably conveys, transfers and assigns to Assignee, its successors and assigns, all of Assignor's worldwide right, title and interest in and to the Acquired Intellectual Property Rights, including without limitation: (a) the Marks, all common-law rights therein, and all registrations and applications therefor identified on Schedule A, together with the goodwill of the business symbolized thereby; (b) the Domain Names identified on Schedule B; (c) the Copyrights identified on Schedule C; (d) all other trademarks, service marks, trade names, domain names, works of authorship, copyrights, trade secrets and all other intellectual property rights included in the Acquired Intellectual Property, including without limitation all patent, trade secret, copyright and other artistic, literary and moral rights, database, mask work, trademark, service mark, trade dress right and domain name rights and all goodwill associated therewith, and all other intellectual property and proprietary rights, in any of the foregoing

Assignor further assigns to Assignee all of Assignor's rights (i) in and to causes of action and enforcement rights associated with the Marks, Domain Names, Copyrights and other Acquired Intellectual Property, including, without limitation, all rights to pursue damages, injunctive relief and other remedies for past and future infringement or other violation of the

Marks, Domain Names, Copyrights and other Acquired Intellectual Property and (ii) to apply in any or all countries of the world for patent, trademark and copyright protection for the Acquired Intellectual Property.

Assignor agrees that it will, at Assignee's expense, place each of the Domain Names in "unlocked" status and provide to Assignee the applicable Internet domain name registrars' transfer authorization codes for each of the Domain Names or any required information to effectuate the transfer of Assignor's right, title, and interest in the Domain Names (including all account login and password information) to Assignee and do all things necessary, proper or advisable to reasonably assist Assignee in transferring such Domain Names.

The Assignor shall provide to the Assignee reasonable cooperation and assistance at the Assignee's request, without charge but at the Assignee's expense (including the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens and other documentation as may be reasonably required): (a) in the preparation and prosecution of any application for registration or any application for renewal of a registration covering the Acquired Intellectual Property, (b) in the prosecution or defense of any cancellation, opposition, infringement or other proceedings that may arise in connection with the Acquired Intellectual Property, including, but not limited to, testifying as to any facts relating to the Acquired Intellectual Property assigned herein, (c) in obtaining any additional protection for the Acquired Intellectual Property that the Assignee reasonably may deem appropriate that may be secured under the laws now or hereafter in effect in the United States or for any or all countries foreign to the United States of America and (d) for the implementation or perfection of the provisions of this Assignment.

Nothing in this Assignment, express or implied, is intended or shall be construed to confer upon, or give to, any person or entity, other than the parties to this Assignment, any rights, remedies, obligations or liabilities.

This Assignment shall bind and inure to Assignee and Assignor and their respective successors and assigns.

This Assignment may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same.

In the event of a conflict between this Assignment and the Principal Agreement, the terms and conditions of the Principal Agreement shall take precedence.
