RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of March 31, 2014 (this "**Release**"), by JPMORGAN CHASE BANK, N.A., ("**JPMCB**"), as Collateral Agent. Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Security Agreements, as applicable, referred to below.

A. Reference is made to (i) the Credit Agreement dated as of August 11, 2005, as amended and restated as of June 9, 2009, as further amended by the First Refinancing Amendment dated as of January 31, 2011, as further amended by the Second Refinancing and Incremental Amendment dated as of March 11, 2011, as further amended by the Third Amendment dated as of November 10, 2011, as further amended and restated by the Fourth Amendment dated as of March 2, 2012, as further amended and restated by the Fifth Amendment dated as of December 17, 2012, as further amended and restated by the Sixth Amendment dated as of March 8, 2013, and as further amended by the Seventh Amendment dated as of February 7, 2014 (as further amended, restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), among SunGard Data Systems Inc. (the "**Company**"), SunGard Holdco LLC ("**Holdings**"), the Lenders from time to time party thereto and JPMCB, as Administrative Agent, (ii) the Security Agreement dated as of August 11, 2005 (as amended, restated, supplemented or otherwise modified from time to time), among Holdings, the Company, Solar Capital Corp., the other Subsidiaries from time to time party thereto and JPMCB, as Collateral Agent, (iii) the Intellectual Property Security Agreement dated as of August 11, 2005 (as amended, restated, supplemented or otherwise modified from time to time), among Holdings, the Company, Solar Capital Corp., the other Subsidiaries from time to time party thereto and JPMCB, as Collateral Agent, (iv) the Trademark Security Agreement dated as of November 17, 2008, among Holdings, the Company, SunGard Availability Services LP and JPMCB, as Collateral Agent (the documents set forth in clauses (ii) and (iv), the "**Security Agreements**").

B. Pursuant to the Security Agreements, the Grantors granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all right, title and interest of the Grantors in, among other things, the Trademarks set forth on Schedule I hereto (the "**Trademark Collateral**"), which security interests were recorded with the United States Patent & Trademark Office on (i) September 9, 2005 at Reel/Frame 003160/0163, (ii) September 19, 2007 at Reel/Frame 003624/0264, and (iii) December 19, 2008 at Reel/Frame 003907/0165.

C. The Company has notified the Collateral Agent that it intends to effect the spin-off (the "**Spin-Off**") of the AS Business substantially on the terms and conditions contemplated by the Credit Agreement. In reliance upon such notification, the Collateral Agent acknowledges that any and all security interests it may have in the Trademark Collateral pursuant to the Security Agreements have been automatically released.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby release, relinquish and discharge any and all security interests it has in the Trademark Collateral. This Release is made without representation or warranty by, or recourse to, the Collateral Agent or any other Secured Party.

AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.
