WITH RESPECT TO THE CONVERSION OF
A MARYLAND CORPORATION

A MARYLAND LIMITED LIABILITY COMPANY**

These Articles of Conversion are submitted to convert the following Maryland corporation into a Maryland limited liability company, in accordance with Subtitle 9 of Title 3 of the Maryland General Corporation Law (the "MGCL") and Subtitle 11 of the Maryland Limited Liability Company Act (the "MLLCA").

1. The name of the Maryland corporation converting into a Maryland limited liability company is QC Corporation (the "Existing Entity") and the original articles of incorporation of the Existing Entity were filed with the Maryland Department of Assessments and Taxation on March 24, 1988.
2. The name of the Maryland limited liability company into which the Existing Entity is being converted is QC LLC (the "Converted Entity").
3. Such conversion has been approved in accordance with Subtitle 9 of Title 3 of the MGCL and Subtitle 11 of the MLLCA.
4. The issued and outstanding capital stock of the Existing Entity shall be converted into membership interests in the Converted Entity on a pro rata basis.




