TO THE ARTICLES OF INCORPORATION

The undersigned certify that:

1. They are the President and Secretary of TEN FARMS INC., a California Corporation (the "Corporation").

2. Article One of the Articles of Incorporation of this Corporation is amended to read as follows:

The name of this corporation is ADTILE TECHNOLOGIES INC.

3. Article Four of the Articles of Incorporation of this Corporation is amended to read as follows:

The Corporation is authorized to issue two classes of stock to be designated "Common Stock" and "Preferred Stock," respectively. The total number of shares which the Corporation is authorized to issue is Ten Million (10,000,000) shares. The total number of shares of Common Stock the Corporation is authorized to issue is Eight Million (8,000,000) and the total number of shares of Preferred Stock the Corporation is authorized to issue is Two Million (2,000,000). The Preferred Stock may be issued from time to time in one or more series. The Board of Directors is authorized to fix the number of shares of any series of Preferred Stock and to determine the designation of any such series. The Board of Directors is further authorized to determine or alter the rights, preferences, privileges and restrictions granted to or imposed upon any wholly unissued series of Preferred Stock and, within the limits and restrictions stated in any resolution or resolutions of the Board of Directors originally fixing the number of shares constituting any series, to increase or decrease (but not below the number of shares of each series outstanding) the number of shares of any such series subsequent to the issuance of shares of that series.

4. The foregoing Amendments to the Articles of Incorporation of the Corporation have been duly approved by the Board of Directors.

5. The foregoing amendment of the Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with sections 902 and 903 of the California Corporations Code. The number of outstanding shares of Common Stock of the Corporation is One Million (1,000,000). The number of shares voting in favor of the

amendment equaled or exceeded the vote required. The percentage vote required was greater than fifty percent (50%) of the shares of Common Stock.
