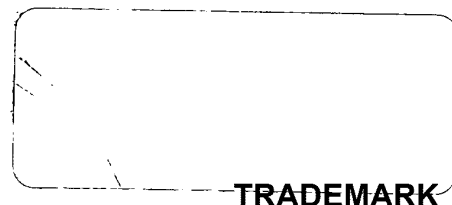

INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (this “**IP Assignment**”), effective as of December 4, 2013 (the “**Effective Date**”), is made by and between White Rose Inc. (as successor by merger to White Rose Food Corp. a/k/a White Rose Food), a Delaware corporation (“**White Rose**”), and Associated Food Stores, L.L.C., a New York limited liability company (“**Associated**”), pursuant to Section 2.02(a)(ii) of the Transfer Agreement, dated as of the date hereof, among White Rose, Associated and Associated Wholesalers, Inc., a Pennsylvania corporation (the “**Transfer Agreement**”). White Rose and Associated may be referred to hereinafter collectively as the “**Parties**” and individually as a “**Party**.” All capitalized terms used but not defined hereinafter shall have the meanings ascribed to them in the Transfer Agreement.

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

- Transfer and Assignment of the Transferred IP.** White Rose does hereby assign, transfer and convey to Associated, its successors and assigns, exclusively, in perpetuity and throughout the world, all of such White Rose’s right, title and interest in and to the Transferred IP, including but not limited to the registered intellectual property set forth on Schedule A of this IP Assignment, and any and all governmental registrations and pending applications and common law rights with respect thereto, in each case free and clear of any Encumbrance (other than Permitted Encumbrances), together with any goodwill symbolized by or associated with such Transferred IP, together with that portion of White Rose’s business to which the Transferred IP pertains, and all claims for damages by reason of past or current infringement of same, with the right to sue for and collect the same for its own use and the enjoyment of its successors, assigns or other legal representatives.
- Binding Instrument; Terms of the Transfer Agreement.** This IP Assignment shall be binding upon and inure to the benefit of the Parties hereto and their respective successors and assigns. All representations, warranties, covenants, agreements and indemnities contained in the Transfer Agreement or any other agreement executed by the Parties in connection with the transaction contemplated by the Transfer Agreement (the “**Transaction Agreements**”) shall survive the execution and delivery of this IP Assignment and shall continue in full force and effect, in each case, as and to the extent provided in the Transaction Agreements. If there is any conflict between the terms and provisions of this IP Assignment and those of the Transfer Agreement, the terms of the Transfer Agreement shall control.
- Counterparts.** This IP Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this IP Assignment delivered by facsimile, email or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this IP Assignment.
- Governing Law.** This IP Assignment shall be governed by and construed in accordance with the internal laws of the State of Delaware without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction).
- Recordation Request.** The Parties hereby request that the Deputy Under Secretary of Commerce for Intellectual Property and Deputy Director of the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign countries, record Associated as the assignee and owner of the Transferred IP set forth on Schedule A of this IP Assignment.

6. **Further Assurances.** Each of the parties hereto shall execute and deliver, at the reasonable request of the other party hereto, any further documents or instruments of assignment, conveyance, transfer and confirmation necessary to perfect or register the interest of Associated in and to the Transferred IP.


