TRADEMARK ASSIGNMENT

WHEREAS, Tribune Broadcasting Company, LLC, a Delaware limited liability company, (the "Assignor") is the current owner of the registered trademarks and service marks set forth on Exhibit A hereto and incorporated herein (collectively, the "Marks"); and

WHEREAS, pursuant to the Fourth Amended Joint Plan of Reorganization for Tribune Company and its Subsidiaries Proposed by the Debtors, the Official Committee of Unsecured Creditors, Oaktree Capital Management, L.P., Angelo, Gordon & Co., L.P., and JPMorgan Chase Bank, N.A., as confirmed by the United States Bankruptcy Court for the District of Delaware, Assignor shall assign and Tribune Broadcasting Hartford, LLC, a Delaware limited liability company, (the "Assignee") shall acquire, Assignor's right, title and interest in and to the Marks, as successor to Assignor's business or portion of the business to which the Marks pertain.

NOW THEREFORE, effective as of this December 12, 2012, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby conveys, assigns, transfers and delivers absolutely to Assignee, its successors and assigns free from encumbrances, all of Assignor's right, title and interest in and to the Marks set forth on Exhibit A hereto and the registrations and applications for registration, together with the goodwill of the Assignor which is symbolized by such Marks and all rights and powers arising or accrued therefrom including, without limitation, the right to sue and recover damages and other remedies for future and past infringements of such Marks and to fully and entirely stand in the place of Assignor in all matters related thereto. Assignor does further consent to the recordation of this Assignment by the Assignee with the Director of the U.S. Patents and Trademark Office and covenants to take such further action and to execute, acknowledge and deliver to the Assignee, at the request of the Assignee, such instruments and take such other actions, at any time and from time to time after the execution of this Assignment, as may be otherwise necessary to perfect the Assignee's title in and to the applicable Marks.


