

The undersigned certify that:

1. They are the President and the Secretary, respectively, of SeekTech, Inc., a California corporation (the "Company").

2. The Articles of Incorporation of the Company are amended and restated in their entirety to read as follows:

I.

The name of the Company is SeaScan, Inc. (the "Company").

II.

The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California, other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code.

III.

The Company is authorized to issue only one class of shares of stock. The total number of shares of stock that the Company is authorized to issue is one million (1,000,000).

IV.

A. The liability of the directors of the Company for monetary damages shall be eliminated to the fullest extent permissible under California law.

B. The Company is authorized to provide indemnification of agents (as defined in Section 317 of the California Corporations Code) through bylaw provisions, agreements with agents, vote of shareholders or disinterested directors, or otherwise, in excess of the indemnification otherwise permitted by Section 317 of the California Corporations Code, subject only to the limits set forth in Section 204 of the California Corporations Code with respect to actions for breach of duty to the Company or its shareholders.


3. The foregoing amendment and restatement of the Articles of Incorporation of the Company has been duly approved by the Board of Directors of the Company.

4. The foregoing amendment and restatement of the Articles of Incorporation of the Company has been duly approved by the required vote of shareholders in accordance with


Section 902 of the California Corporations Code. The Company has one class of stock outstanding. The total number of outstanding shares of the Company is 7967.24. The number of shares voting in favor of the amendment and restatement equalled or exceeded the vote required, such required vote being more than 50% of the outstanding shares.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.
