TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Agreement") is made by and between CONCORDIA PHARMACEUTICALS, INC., a corporation organized under the laws of Barbados ("Concordia") and FULCRUM CAPITAL PARTNERS, INC., a corporation organized under the laws of Canada ("Fulcrum").

WHEREAS, pursuant to an Intellectual Property Security Agreement (the "Security Agreement"), Concordia executed and delivered a Collateral Assignment for Security (Trademarks) dated May 6, 2013, under which Concordia granted to Fulcrum a security interest in all right, title and interest of Concordia in and to the United States trademarks listed in Exhibit A attached hereto, together with the goodwill of the business symbolized thereby and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist be reason of infringement thereof, to secure the prompt payment and performance of the underlying Secured Obligations as defined in the Security Agreement (collectively, the "Collateral");

WHEREAS, the Security Agreement was recorded in the records of the United States Patent and Trademark Office (herein referred to as the "USPTO") on May 15, 2013 and such recordation is located on Reel 5028 at Frame 0243 of the USPTO; and

WHEREAS, Concordia has satisfied all of its obligations under the Security Agreement and has requested that Fulcrum terminate and release its security interests in and liens on the Collateral as herein provided.

NOW THEREFORE, to all who it may concern be it known that Fulcrum hereby (a) releases and discharges all interests in the Collateral that were granted by the Security Agreement, and (b) acknowledges, confirms and agrees that the Security Agreement is discharged, released and terminated and of no further force or effect with respect to the Collateral.
